9. WEI Report	Stoyan Bumbalov reviewed the 2022 Meeting schedule, indicating the February 16 WEI meeting had been cancelled. The roles of Ecotope and the Workgroup of Economic Impact were explained. 10. IBC/IFC Hearing Report	Stoyan Bumbalov reviewed the 2022 Code Review and Adoption schedule indicating the first public hearing was held February 11. It was noted the recording and testimony will be posted on the website.
